



#### REPORT OF BROUGHTON GIFFORD PARISH COUNCIL MEETING - 4TH FEBRUARY 2009

District Councillor Carbin was present for most of the meeting. However, Mrs Jarvis and Mr Hall both had family commitments and had sent apologies. County Councillor Clark and PCSO Ledbury had also sent apologies.

**MATTERS ARISING** It was reported that the far section of wall outside 93/94 The Common was never actually built. Overall the site was tidier, considering the amount of work being done to the property. However, there was a manhole cover nearby that had been damaged by a delivery lorry. This would be brought to the owner's attention and he would also be reminded him if he wished to make another access to his property over the Common he must initially seek permission from the Parish Council before he proceeds.

The Clerk had written to the Headteacher at St Mary's School asking if the School would support the Parish Council's request to the County Council to install flashing warning signs to alert drivers to the possible presence of school children at the beginning and end of the day. She had responded by email giving full support, stating that it could only improve the safety for the children, especially since its 'Travel to School Plan', to be submitted to the County Council by the end of March 2009, would include its proposal to commence a 'Walking Bus' system for the children. The Clerk would now contact the Road Safety Team with this request, stating full support from the School.

PCSO Ledbury had advised that there was currently a clamp down on untaxed vehicles and as the Common is part of the highways vehicles parked on all parts of the Common without valid tax discs will be reported. The green van, on which the tax expired at the end of December 2008, had been declared SORN (Statutory Off Road Notice) but was now parked directly in front of a garage. This was still part of the Common and therefore it remained parked on the 'highway' despite being declared otherwise. A letter would be sent to the owner asking for the vehicle to either be immediately taxed or removed from public land, indicating that the Police had initially reported this problem to the Parish Council, so it is currently at risk of further action being taken by the Police.

A suggestion of 'Brooke Close' had been received as a name for the new development, which would be considered nearer the time.

Mr Gurney invited Trevor Carbin to report on District Council matters. Mr Carbin advised that owing to the recent spell of poor weather some refuse collections had not been made but green bins should be left out as they could be collected anytime. Black boxes on the other hand should be taken back in as they will not be collected until the next scheduled collection day. The budget process is underway and under Wiltshire Council the Council Tax is proposed to be increased by 3.5%, despite the promised savings of going unitary, as the costs involved in the changeover almost outweigh any savings made. However, figures produced to support this are not clear. Proposed changes in the future include charging for internet use in libraries and possible charging for green compostable waste, as this is already in place in other districts. Mr Atkins questioned about the double charge for this service since we already pay for refuse collection through the Council Tax. The 3.5% increase is an average figure, since some districts will have to be charged more and some less to compensate for the differences in existing levels of Council Tax. Mr Carbin advised that the District Council had previously agreed to look into the possibility of councils providing some cover for the removal of Post Office services in the District but nothing more had been heard as he felt this had been superseded by the move to unitary. Mr Wiltshire asked Mr Carbin about the Area Boards, currently being piloted in some areas ready for rollout throughout the County, stating their similarities to district councils since they will have power to spend public money. He asked whether parish councils will have the opportunity to 'opt-in' on matters concerning them but then step back on other matters or will it have to commit a representative to attend every meeting. Also will parish councils have access to the funds available. Mr Carbin stated he was unsure how the system will work at the moment or how the structure of these Boards will be made up, but confirmed that only unitary councillors will have voting rights, with other details being a little vague until nearer the time. Mr Gurney thanked Mr Carbin for his report.

#### **CORRESPONDENCE**

Mrs Liz Lumley had forwarded a receipt for the payment made in respect of the Poppy Day Wreath and confirmed that a total of £920.09p had been raised in the Village this year. The Clerk thanked her for her hard work for this good Wiltshire County Council confirmed in its monthly newsletter that it operated over 1200 grit bins in the County, re-filled an average 350 following public enquiries and asked for assistance from parish and town councils in the management of these bins. This was to ensure those in regular use are kept topped up, local knowledge could be passed on regarding the location of any new bins required and also those not in use would be removed during the coming summer. However, each parish will be contacted and provided with a map of which bins they wish to remove before any action is taken.

The District Council invites members to an information evening about the transition to Area Boards on Wednesday 11<sup>th</sup> March starting at 7pm at Bradley Road offices. Mr Coward will try to attend, possibly accompanied by Mr Wiltshire.

WALC monthly newsletter invited nominations to attend a garden party at Buckingham Palace on 21<sup>st</sup> July 2009. The Parish Council would nominate the Chairman and his wife to attend. It also confirmed that the 2008/9 pay dispute regarding local government employees will now be taken to arbitration. West Wilts Link Scheme was asking for more volunteers to come forward to help with its increasing demand for its services.

Mr Hudson reported on a clever idea suggested by a paramedic regarding the insertion of an emergency contact phone number into a mobile phone to be used if the owner is unfortunate to be involved in an accident or taken ill and is unable to use the mobile themselves, or communicate with those attending him/her. Under 'ICE' (In Case of Emergency) the next of kin, relative or friend could be easily contacted and advised of the situation, with multiple contacts being entered as 'ICE 1', 'ICE 2' etc. Details would be included in the Magazine.

The application for various trees works at Orchard Farm considered last month had since **PLANNING** been withdrawn, to be replaced by a revised application, with the main difference being that a Blue Atlas Cedar is to be crowned rather than felled. The Parish Council had no objections. The application for two storey side and rear extensions with a single storey extension at 72 The Common had been granted permission despite being recommended for refusal by the Planning Officer. Members of the Planning Committee overturned this recommendation at its meeting held on 8th January. application for the installation of three solar panels on the southern roof-space of the barn at Church Farm had been refused. Mr Hooper and Mr Taylor declared an interest in this item. The application is likely to be resubmited in due course as this refusal had resulted in the permitted development status being withdrawn from the barn and as such no further work can be carried out on it. It appeared odd that similar installations had been carried out on nearby properties without any problem and considering the current emphasis on switching to renewable energy. An application had been received for the addition of a dormer window to the rear of 12 The Street. One objection was raised due to the window looking out over the neighbouring property of Egerton Farm. However the majority of the Parish Council had no objections.

GENERAL MAINTENANCE

A letter received from Wiltshire County Council Highways indicated that flooding in Mill Lane appears to be a land drainage problem rather than a highway one and asked to be advised of the owner of the field opposite number 164 so that he can request the ditches be cleared out and would be advised accordingly. The BT junction box outside Priory Farm had been exposed but was programmed for reinstatement. The Parish Council had been advised to contact Wiltshire Safety Camera Unit regarding speed indicator devices and contact details were provided.

Mr Gurney felt that for the cost of a couple of signs stating 'No Lorries' it was worth continuing to push for action to stop lorries using Mill Lane, usually following satellite navigation systems. Mr Taylor reported that he had recently purchased a new satnav that again indicated Mill Lane as the most direct route in and out of the Village and had advised the manufacturer of this error. The Parish Council would continue to pressure WCC Highways on this matter.

Norrington Lane was still regularly flooding with excess water pouring off the fields quicker than it was being drained off the highway. This matter, as well as the continuing water flowing across the road near Hitherkings would again be brought to the attention of Wiltshire Highways.

Highway matters to be reported or chased up included: When would the fingerpost at the Norrington Lane junction, removed some time ago for renovation, be replaced? The road surface outside 29a The Street was badly degrading and would shortly be breaking up if not repaired. There was a large pothole just

inside D Mortimer & Sons entrance, sometimes used by vehicles to pass large oncoming traffic and a large pothole in the road on Melksham Lane between Priory Farm and Frying Pan Farm. There were large amounts of mud on the highway surface along Mill Lane. The village name sign at the Holt end of Village, promised to be replaced with new one sometime ago, but no action had yet been taken.

Incidents of flyposting and flytipping had been reported. These matters would be brought to the attention of the relevant agencies and more information would be highlighted in the Village Magazine.

Extensive amounts of debris in the River Avon being pushed against the Pack Horse Bridge on footpath 26 had been reported, which was in danger of damaging the Bridge and the relevant authority would be advised.

A large amount of rubbish was reported on the Common, next to a telegraph pole at the end of Taylors Lane. It was thought this was left over after building work on a nearby property and the person thought to be responsible would be asked to remove it.

The fence between the Village Hall car park and the paddock was in a state of disrepair and had recently caused an injury to a child. A request would be made for either urgent repairs to be carried out or for it to be removed.

The streetlight on the Common at the end of Taylors Lane and the one outside 11 The Street were both being blocked by overgrown vegetation and would be reported. The streetlight opposite Hollybrook House is out of order and would also be reported.

TRIAL GRAZING ON THE COMMON

It was reported that a local farmer had agreed to graze some rams on the Common, within the terms of the Declaration made by the Parish Council in October 2008 and this was likely to commence in the

ANY OTHER BUSINESS

The Parish Council would write a letter of congratulation to Mr Robert Floyd of Great Chalfield Manor on being appointed High Sherriff of Wiltshire as from 1st April 2009.

Mr Taylor reported that there had been a break-in in Curtis Orchard but nothing had been taken. The Police had been informed.

The Parish Council would enquire with the RSPB about the lack of skylarks on the Common, and how to encourage them back.

#### **FLY TIPPING AND FLY POSTING**

As part of the Clean Neighbourhoods legislation, both fly posting (the display of advertising material including posters and stickers on buildings and street furniture, including road signs, without the consent of the owner and contrary to law) and fly tipping (waste dumped or tipped on a site with no licence to accept waste) are illegal. Both problems can be unsightly, affecting the image of the area and the street scene and can be damaging to the environment. As a duty of care the Parish Council encourages everyone to report incidents of both types, giving as many details as possible:



#### EGERTON HOUSE FARM AND FOOTPATHS

Having very recently moved into Egerton House Farm my wife Angela and I have been struck by how friendly and welcoming everyone has been.

As owners of land adjacent to the village we are conscious of our responsibilities and land with public footpaths increases that responsibility. Though we have made a point of introducing ourselves to as many walkers and villagers as possible, we will never get around everyone and rather than the danger of erroneous Chinese whispers about what the newcomers at Egerton are doing we thought it would be helpful to use the services of the Broughton Gifford Magazine to let you know who we are, what we will be doing and our attitude to the use of the footpaths.

Angela and I have two adult girls both working in the equestrian world and currently overseas. We have come from Devon where we were farming 120 acres under a Higher Level Organic Stewardship scheme. Any of you who know about Natural England's environmental schemes will be aware of the strict and detailed prescriptions on farming and the care of the land, the general aim of which is to manage the land in a way that enhances the environment for animals, birds, insects and humans whilst enabling the proper commercial use of the land. We are in effect caretakers of our countryside for future generations.

Angela has been involved in horses for most of her life, competing at a high level in Dressage, a spell as an amateur flat race jockey, eventing and hunting. She even taught me to ride and probably regrets it now! As the years have passed I have also been an amateur flat jockey, point to pointed and for far too many years have played polo which I still compete in. With this family background in horses our plan is to train and breed young sport horses with one of our daughters who is currently training young showjumpers in Germany. I hasten to say that she will do the hard work!

This brings me to the use of our land at Egerton. We have been here a very short time, but clearly there are a few different interpretations over use of footpaths and land, in particular where it relates to Egerton land. Our intention is to continue use of some fields with the grazing of cattle and possibly sheep, this will help to maintain the land in good heart as horses are notoriously poor grazers. We will have a mixture of Brood Mares, foals, yearlings and horses in training, mainly Showjumping, Dressage and Polo breeds.

Horses, like people, behave differently, at each stage of their life and as such require different handling. For example, horses at rest such as the polo ponies presently on the land are relatively calm, but as soon as they are in work and beginning to get fit they become more flighty and sensitive to noise, movement and handling. Yearlings who are teething can nip and sometimes do not know their own strength, again careful sensitive and knowledgeable handling is essential. I mention this to explain why different fields and paddocks will be used for various horses at

different times of their upbringing.

We will vary the use of fields so it is important to our business that we know which fields will be free of any outside influence such as walkers, dogs or anything else.

Wiltshire is fortunate to have the largest number of footpaths and BOATS per head of population in the country and it is clear from the use made of them at Broughton Gifford that this public access is fully appreciated. Just as landowners have rights over their land so does the public over public rights of way. However both have corresponding duties and must mutually respect the proper use of the land. The land at Egerton is not covered by the Right to Roam Act which mainly covers open moorland and common land.

Egerton Farm has 3 major footpaths, two start and cross what I am told is called "The Village Field" and join up to cross two fields beyond. The third path is the far section going down the right hand side of the hedgerow from the small triangular holding paddock out in the direction of the Common. It clearly has been a custom by some people to cross the large 23 acre field coming back towards the village field and some use the furthest field, both of which do not have public access paths. The Village field is regularly walked around the perimeter as well as across on the designated paths, as are some other fields.

In working out the division and use of the fields we want to take into account the current use by walkers as much as possible. We are also ruled by the business of horses and farming and regrettably by the very small minority who either do not understand or do not care. Specifically, horses have been fed carrots, this could be fatal to an under 3 month foal and encourages horses to nip, approach and "mob" people who might not wish it and could indeed be frightened of them. Gates have been left open. Even if there is no stock in a field it doesn't mean something may not jump out or push through a fence in an adjoining field.

As regards the "village field", by a long way the most used, we wish to see minimal change. We do need to create a small paddock adjoining the current orchard area and will be planting a mixed hedgerow. We are also hoping to improve the potentially beautiful pond and create a conservation haven with a bench where even the fittest of walkers would find pleasure in a place to rest their weary limbs and contemplate life. We would use this field mainly to make hay and at times graze cattle or sheep and ride over. It is unlikely that we would graze this area with horses in order to minimise any risk to both humans and horses. We will need to underline the fact that the circular or any off path route is permissive and not a public right of way. To do this we therefore reserve the right to close it at any time. So, nothing need change on the village field as far as walkers are concerned.

For the rest of the land we would ask everyone to stick to the public footpaths and we would request that dogs are under control, to be under control they do not have to be on leads but within voice or whistle control. Clearly for some dogs walking through stocked fields it is only wise to have them on leads. I am concerned that any dog not under control could easily run into another field or stable area with young or nervous stock. Also I would plead that no one should feed other peoples animals however kind the thought may be.

I hope this article is received in the spirit it is written, one of goodwill and respect for each other. We look forward to a long and happy stay in Broughton Gifford.


